Dear Vendors,

The cost is \$20 per 8 ft wide by 8 ft deep space which includes one (1) 8ft table and two (2) chairs. Additional tables can be rented for \$10.00 per table. If your contract is signed and returned by February 1, 2023, we will give a \$5 discount. This fee is NON-REFUNDABLE unless the event is completely canceled. All tables must be covered on all three sides, down to the floor. Vendor spots are based on consideration of items being offered along with other factors and at the discretion of the Erie County Fair Fall Extravaganza Committee. Every effort will be made to honor location requests but cannot be guaranteed. Electric is available for \$5.00 and is very limited. Vendors must provide their own heavy duty 3-prong extension cord.

Please bring a door prize item valued at a minimum of \$20.00. Reverse door prize giveaway, instead of calling numbers, shoppers will check your table to see if their number matches yours for your door prize.

Setup for vendors will be available Friday from 5:30PM to 7:30 PM and Saturday morning 7:30AM to 9:00 AM. We WILL NOT assume responsibility for lost, stolen or damaged items. The buildings will be locked Friday night.

All contracts along with payment must be returned by February 1, 2023 for the discount to be applied. Contracts received after that date will still be accepted but full payment will be required. Payments can be sent via mail to:
