Units may be taken out: April 10th, 17th, & 24th, 2027 (10 a.m. to 2 p.m.)

## STORAGE AGREEMENT

This storage agreement made this \_\_\_\_\_ day of \_\_\_\_\_, 2026, by and between, the Erie County Agricultural Society (hereinafter referred to as "Lessor") and \_\_\_\_\_ (hereinafter referred to as "Lessee"): Lessor hereby leases and rents to Lessee space in Society's building located at the Erie County Fairgrounds in Sandusky, Ohio to be occupied by Lessee for storage purposes only. Such area to be leased shall be considered a unit and each unit shall be a space for one vehicle, trailer or boat. Society makes no warranties as to suitability, security or otherwise of space. Lessee accepts said space as is: to have and to hold the above-described unit or units The lease term is from October 31, 2026 to April 24, 2027. A penalty of \$5.00 per day will be charged for each day the unit remains after April 24, 2027.

## INDEMNIFICATION AGREEMENT

I, \_\_\_\_\_ (Lessee), hereinafter recognized as the "Lessee," agree to indemnify and hold harmless the Erie County Agricultural Society, hereinafter recognized as the "Society," from any claim, demand, suit, loss, cost of expense, or any damage which may be asserted, claimed, or recovered against or from the Erie County Agricultural Society by reason of any loss of property, damage, injury, or death arising out of or connected with my use of the storage area, regardless of negligence by the "Lessee" or third parties.

### Lessee's Covenants and Agreements:

1. Use the unit for vehicles, trailers, or boat storage only.
2. Follow all rules and regulations set by the Society.
3. Accept all risks of damage from weather, storm, acts of God, rebellion, or riot. and The Society shall not be responsible for any damage or destruction to Lessee's property caused by any persons or trespassed fellow Lessee in any manner.
4. Provide personal insurance for fire, theft, vandalism, damage, or destruction.

### Payment Schedule (per foot of length plus tax):

- Up to 9'11" wide: \$19.00
- For Items wider than 10' – call for pricing and a payment link

-  No flammable or explosive materials allowed.
-  Disconnect or remove batteries before storage.
-  Leave keys with all vehicles.

 **IMPORTANT!** 

### Early removal before April 10, 2027, must be scheduled.

- Unscheduled removal prior to April 10, 2027, will be charged \$25.00 per man, per hour required to get to and remove the unit.
- If the unit is scheduled to be taken out and returned to storage prior to April 10, 2027, there will be an additional charge of \$25. This charge shall apply to each time the unit is removed and returned.
